TERMS AND CONDITIONS

- 1. Receive a \$25 Amazon Gift Card (each, a “Gift Card”) for every Qualifying Purchase (as defined below) made in accordance with these Terms and Conditions.*
- 2. Must be an employee of a Toyota, Lexus, Mazda, Mercedes-Benz or Volvo (the “Participating Automotive Brands”) dealership in the United States to participate (each, an “Eligible Employee”).*
- 3. Referral Information (as defined below) of the Eligible Employee must be entered at check-out page on ChargePoint Applicable Webstores (as defined below) for any of the Participating Automotive Brands.*
- 4. It’s that easy for Eligible Employees to receive Gift Cards!*

Gift Card Referral Program: An Eligible Employee will receive one Gift Card for every ChargePoint Home Flex purchased by a customer referred by such Eligible Employee through one of the following United States webstore links by entering the Referral Information of such Eligible Employee and otherwise complying with these Terms and Conditions (“**Qualifying Purchase**”):

As used in these Terms and Conditions, “**Referral Information**” may require the following information of the applicable Eligible Employee: employee first and last name, dealership name, business phone number and work e-mail address. Purchases made outside of the ChargePoint Applicable Webstores are not eligible for Gift Cards. Gift Cards will only be issued for Qualifying Purchases made during the following period, unless modified by ChargePoint, Inc., in its sole discretion: **July 17, 2023 through and until October 17, 2023**. Gift Cards will be issued monthly for Qualifying Purchases shipped at least thirty (30) days prior to the applicable monthly Gift Card issuance date and will be sent to the work e-mail address of the Eligible Employee that is entered as part of the required Referral Information. An Eligible Employee may receive up to twenty-three (23) Gift Cards per calendar year. Gift Cards will not be issued for cancelled or returned orders. Any and all resulting tax obligations arising from receipt of any Gift Card(s) are the sole responsibility of the Eligible Employee. This Gift Card Referral Program may end at any time, without notice, at ChargePoint, Inc.’s sole discretion.

Eligibility: Eligible Employees must be an employee of one of the Participating Automotive Brand dealerships in the United States at the time of (1) the Qualifying Purchase and (2) Gift Card issuance. ChargePoint, Inc. reserves the right to verify the eligibility of Eligible Employee and, at its sole discretion, may deny Gift Cards for purchase orders that do not meet the requirements set forth in these Terms and Conditions.
